Miss. Jogdand S.K. should report ~~the~~ this office within week from the date of this order for joining the duty.

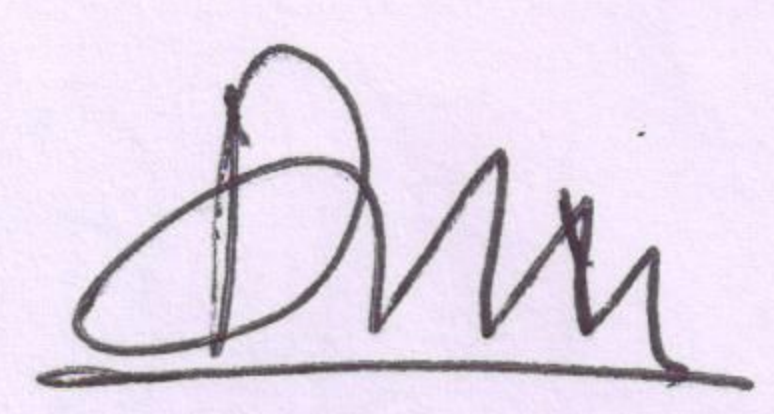
